

# **Capy Gaming US Sweepstakes Official Rules**

## **Updated June 14, 2026 NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

The sole sponsor/promoter of the Sweepstakes is Capy Holdings Inc d/b/a Capy Gaming (“Capy Gaming,” or “Sponsor”).

PARTICIPANTS IN THE SWEEPSTAKES (DEFINED BELOW) MUST REGISTER AND MAINTAIN AN ACCOUNT WITH SPONSOR AND ACCEPT THE TERMS OF USE (“TERMS”), WHICH IN TURN INCORPORATE AND APPLY TO THESE OFFICIAL RULES. THESE OFFICIAL RULES GOVERN AND CONTROL THE SWEEPSTAKES OFFERED BY SPONSOR AND ARE CONSIDERED TO BE PART OF THE TERMS. PLEASE NOTE THAT THESE RULES INCORPORATE SECTION 16 OF THE TERMS, WHICH INCLUDE MANDATORY BINDING ARBITRATION AND CLASS ACTION WAIVER PROVISIONS. ANY CAPITALIZED TERMS NOT EXPRESSLY DEFINED IN THESE OFFICIAL RULES HAVE THE MEANING SET FORTH IN THE TERMS.

1. Sponsor/Promoter Capy Holdings Inc d/b/a Capy Gaming, a Nevada corporation, whose mailing address is 6260 Spring Mountain Rd, Ste 100, Las Vegas, NV 89146, is the Sponsor/Promoter of the Sweepstakes. The Sweepstakes is sponsored and administered solely by Capy Gaming. Apple Inc., Google, and Meta are not sponsors of, affiliated with, involved with, or responsible for this Sweepstakes in any manner. 2. Eligibility

The Sponsor Sweepstakes (the “Sweepstakes”) is open only to legal residents of the United States (excluding Connecticut, California, Idaho, Louisiana, Michigan, Montana, Nevada, New Jersey, New York, and Washington, and where otherwise prohibited) who are twenty one (21) years of age or older at the time of entry.

The following individuals are not eligible to enter or win a Prize (defined below): officers, directors, employees, agents and representatives, of the Sponsor, its parents, subsidiaries, affiliated companies, or of any other parties involved in the operation of the Sweepstakes (Sponsor, collectively with the foregoing, the “Sweepstakes Parties”) and each of the immediate family members of such excluded individuals (i.e., spouses, parents, children, siblings and the “steps” of each) and all persons living in the same household of each.

By participating in this Sweepstakes, entrants (“Entrants” or “Participants”) agree to be bound by these official rules (“Official Rules”) and by the decisions of the Sponsor, which shall be final in all matters relating to the Sweepstakes. Winning a Prize is contingent upon fulfilling all requirements set out in these Official Rules. If a Participant is, in the Sponsor/Promoter’s best judgment, determined to have participated in unethical behavior, the Sponsor/Promoter reserves the right to limit or exclude the Participant from the Sweepstakes.

The Sweepstakes is subject to all applicable federal, state, provincial, territorial and local laws and regulations. It is the sole responsibility of a Participant to determine whether the Sweepstakes is legal and compliant with all regulations in the jurisdiction in which the Participant resides.

### **3. Overview**

Sponsor provides promotional sweepstakes entries referred to as “Capy Coins” (“CC” or “Sweepstakes Coins” / “SC”). Capy Coins may be used to play sweepstakes games for a chance to win additional Capy Coins that may be eligible for redemption for Prizes in accordance with these Official Rules.

Capy Coins are promotional in nature and do not constitute real currency. Redemption is subject to verification and compliance with these Official Rules.

4. Sweepstakes Entry Period The Sweepstakes, as set forth in these Rules, begins on the first day of the current month at 12:00:00 a.m. Eastern Standard Time (EST) and is scheduled to end on the last day of the current month at 11:59:59 p.m. EST, or when Capy Gaming provides thirty (30) days’ prior notice of termination, whichever occurs first. Sponsor’s computer is the official time-keeping device for the Sweepstakes.

### **5. Odds of Winning**

Odds of winning virtual coins will vary for each Game and will be published by the Sponsor and visible to all Participants on the Platform.

Sponsor reserves the right to change the Prize win rates and payout odds of any of the games at any time. A participant can obtain the actual and any amended details of any game at the point of entering an amount to play in the game. It is a participant's responsibility to check the Prize available on each occasion before they participate.

## 6. How to Collect Capy Coins

To participate, You must have an active account with Capy Gaming ("User Account"). If You do not have a User Account, You can create one free of charge at [www.capyspin.us](http://www.capyspin.us) (the "Site"). To enter the Sweepstakes, a Participant must access the Site and sign into their User Account.

Once a Participant has accessed the Site, there are several potential ways for an eligible Participant to collect Capy Coins:

A. Receive a Specific Number of Free Capy Coins By Collecting a Daily Reward ("Daily Logon Reward"): The specific number of free Capy Coins may vary by day and will be prominently displayed on the Platform. You can receive free Capy Coins on a daily basis by taking the following steps: (i) sign into your User Account, and if you are eligible, a pop-up screen will appear for you to claim your Daily Logon Reward; and (ii) click the "Claim" button at the bottom of the Daily Logon Reward pop-up. Participants can only claim a Daily Logon Reward once per day (the daily clock resets daily at midnight ET). Participants can also win a variety of Capy Coins from the Wheel Spin events.

B. Receive Capy Coins as a Free Bonus When Purchasing Orange Coins: Participants may receive Capy Coins ("CC") as a promotional bonus when purchasing specifically designated Orange Coin ("OC") packages. Orange Coins are virtual coins used solely for gameplay and entertainment purposes and are not redeemable for Prizes. The number of Capy Coins awarded as a bonus in connection with any Orange Coin purchase will be clearly displayed on the Platform at the time of purchase. All purchases of Orange Coins are final and non-refundable, except as required by applicable law.

C. Receive Capy Coins for Free When Entering Capy Coins No-Cost Giveaway Contests on the Capy Gaming Social Media and Marketing Pages: The Sponsor reserves the right to hold Capy Coins no-cost giveaway contests which users can enter by following instructions that will be provided on the Capy Gaming social media pages. These giveaways may require sharing posts or answering various game related questions to be eligible for entry. The amount of Capy Coins given away will be stated on the applicable Capy Coins no-cost contest post, and will be credited to each contest winner's account at the conclusion of the giveaway. These giveaways may be subject to additional restrictions and rules as referenced in the giveaway materials at the time of the contest, as well as in the Official Rules in effect at the time. D. Receive Capy Coins for Free by Referring a Friend: Participants may receive Capy Coins by referring up to ten (10) new users in accordance with the terms on our Referral Program page.

E. Mail-In Entry: An Authorized Account Holder (defined below) can receive free Capy Coins via a mail-in request ("AMOE"), as follows:

a. Receive an Envelope Request Code (as explained below) and address and deliver a standard, white, one-sided, unfolded, unlined #10 envelope, posted from the same state as the participant's verified residential address to Sponsor at the following address:

b. Include the following information on a standard, white, one-sided, unfolded, unlined 4x6 index card in the same order as follows:

i. the Authorized Account Holder's full name as shown on the Authorized Account Holder's government issued identification;

ii. the e-mail address registered to the Authorized Account Holder's Capy Gaming account;

iii. the residential address registered to the Authorized Account Holder's Capy Gaming account;

iv. the Envelope Request Code;

v. Include the following handwritten statement on the 4x6 index card: "Sweepstakes Entry! I wish to receive Capy Coins to participate in the [Insert Month Of Sweepstakes Contest] Sweepstakes Contest offered by Capy Gaming. By submitting this request, I hereby declare that I have read, understood and agree to be bound by Capy Gaming Terms of Use and these Official Rules." vi. IMMEDIATELY BENEATH THE HANDWRITTEN STATEMENT, THE AUTHORIZED ACCOUNT HOLDER MUST (I) SIGN THE INDEX CARD AND (II) WRITE THE DATE OF SIGNATURE IN MM/DD/YYYY FORMAT.

c. LIMIT ONE (1) MAIL-IN ENTRY PER OUTER ENVELOPE.

d. THE COMPANY ADDRESS AND ALL SUCH INFORMATION LISTED ON THE 4X6 INDEX CARD MUST BE HANDWRITTEN SOLELY BY THE PARTICIPANT. A Participant must ensure that their handwriting is legible. If the Participant's handwriting is not legible, the entry will be void and the Capy Coins will not be credited to the participant's User Account. The legibility of a Participant's handwriting will be determined by Sponsor/Promoter in its sole discretion.

Participants must personally and physically handwrite each index card with the Envelope Request Code generated on that Participant's User Account, cards submitted for or on behalf of any other person will be void. Cards completed utilizing any method which simulates handwriting will not be accepted and will subject the participant to forfeit all entries, account closure, and/or any other action deemed necessary in Sponsors sole discretion.

e. The signature on the postcard must match, in Capy Gaming's sole discretion, the signature on the verified identification card on Authorized Account Holder's Capy Gaming Account.

f. An Envelope Request Code is a unique combination of 12 digits that participants can obtain by following the steps outlined in these Official Rules. An Envelope Request Code is unique, can only be used once and expires 30 days after it is displayed. The purpose of an Envelope Request Code is to assist with the efficient

and effective processing of a participant's Request Card. Request Cards containing an expired Envelope Request Code at the time of processing will be void. AN ENVELOPE REQUEST CODE CAN ONLY BE USED BY THE PARTICIPANT WHOSE CUSTOMER ACCOUNT WAS USED TO GENERATE THAT ENVELOPE REQUEST CODE. Any participant suspected by Sponsor to have directly or indirectly provided a Envelope Request Code to another person may, in the sole discretion of Sponsor, be disqualified and lose their eligibility to participate in the Sweepstakes. An Envelope Request Code can be obtained by following the following steps:

i. sign into your User Account;

ii. [click on the "Envelope Code Request" link on the home screen and follow the prompts.] The Envelope Request Code is then displayed for a period of time to enable a Participant to record it on their Request Card.

g. A Participant will receive [three (3)] Capy Coins per valid mail-in request. Subject to verification and compliance as set forth in these Official Rules, the Capy Coins will be added to the Participant's User Account.

If Capy Gaming believes, in its sole discretion, that an Entrant is abusing the AMOE process or otherwise engaging in conduct prohibited by, or not in accordance with, these Rules or the Terms of Use, the Company may take any action permitted by these Rules or the Terms of Use, including but not limited to, terminating a user account, suspending or voiding an AMOE request, or requiring a video verification process. Capy Coins may be forfeited if a participant's User Account is closed for any reason, including at the Sponsor's discretion. Sponsor may, from time to time, offer additional promotional features, campaigns, or events through which eligible Participants may receive Capy Coins, including but not limited to jackpots, referral programs, bonus events, limited-time offers, welcome offers, mobile launch offers, promo-code or email rewards, sign-up or reactivation rewards, Capy Pass rewards, Streak Saver-recovered Daily Logon Rewards, wheel or draw rewards, tournaments, leaderboards, provider cups, weekend events, or other special promotions. The terms, conditions, eligibility, claim method, rewards, expiration, and applicable gameplay requirements for such promotions will be displayed on the Platform or in the applicable promotion materials at the time of participation. All promotional offers are subject to verification, account standing, fraud review, and Sponsor's right to change, suspend, or terminate the promotion at any time in its sole discretion.

## 7. Using Capy Coins to Play Games

Entrant must be the Authorized Account Holder of the e-mail address used in connection with the Entry. The "Authorized Account Holder" is defined as the natural person to whom the e-mail address is assigned by an internet service provider, online service provider or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

Participants with Capy Coins can use their Capy Coins to play sweepstakes games on the Platform for a chance to win additional Capy Coins. Capy Coins accumulated through game play can be redeemed for Prizes of monetary value in accordance with these Rules. Only games played with Capy Coins provide the opportunity to win additional Capy Coins that may be redeemed for Prizes subject to these Rules.

Capy Coins that have been won through game play (rather than collected using one of the methods described in Section 6 above) and are accumulated by Participant may be redeemed for

a Prize, subject to maximum and minimum Prize redemption amounts stated in these Official Rules. Capy Coins possess no real monetary value and may only be used to request a Prize redemption to be approved and processed by the Sponsor. Approval is subject to participant completing all verifications to confirm eligibility and adherence to all Sweepstakes Rules and Terms of Use of the Platform. The use of automated or systematic methods of play to win and/or redeem Capy Coins for Prizes is strictly prohibited. Utilizing methods such as utilizing multiple accounts and identities and other collusive methods are not permitted and may result in account closure and forfeiture of Capy Coins, in the sole discretion of Sponsor.

Sponsor's decisions as to the administration and operation of the Sweepstakes, the game and the amount of winnings are final and binding.

Capy Coins obtained through any method described in Section 6 are not immediately eligible for redemption. Capy Coins must first be used in eligible gameplay and must satisfy the applicable gameplay requirement assigned to the source of those Capy Coins. Unless otherwise stated on the Platform or in the applicable promotion: (a) purchase-price-equivalent Capy Coins included with an Orange Coin package generally require one (1) use in eligible gameplay; (b) discounted, extra-value, or bonus Capy Coins awarded in connection with an Orange Coin purchase generally require two (2) uses in eligible gameplay; and (c) free, event, or promotional Capy Coins generally require three (3) uses in eligible gameplay. Free, event, or promotional Capy Coins may include, without limitation, Daily Logon Rewards, sign-up rewards, reactivation rewards, email or promo-code rewards, tournament or leaderboard rewards, referral rewards, social giveaway rewards, wheel or draw rewards, free or trial Capy Pass rewards, Streak Saver-recovered Daily Logon Rewards, and other promotional rewards. Capy Pass rewards purchased by a Participant may be treated as purchase-related value for the purchase-price-equivalent portion and as package or promotional bonus value for any additional value, as displayed on the Platform.

Only Capy Coins that have been won or accumulated through eligible gameplay after satisfying the applicable gameplay requirement, and that otherwise satisfy these Official Rules, may be submitted for a Prize redemption request. Sponsor may require additional review or impose a different gameplay requirement when required by promotion terms, abuse controls, account standing, technical correction, or applicable law, provided that such requirement shall not exceed thirty (30) uses in gameplay unless otherwise separately disclosed and agreed.

Sponsor reserves the right, at its sole discretion, to investigate and take action against any suspected abuse, including but not limited to:

- Multi-accounting
- Syndicated or coordinated play
- Abuse of promotional mechanics
- Use of unauthorized tools or automation

Such actions may include suspension, account termination, forfeiture of Capy Coins, and denial of redemption requests.

## **8. Verification & Confirmation of Potential Winners**

POTENTIAL SWEEPSTAKES WINNERS ARE SUBJECT TO VERIFICATION BY SPONSOR/PROMOTER (IN ANY MANNER IT MAY CHOOSE) AND THE DECISIONS OF SPONSOR ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE SWEEPSTAKES. A PARTICIPANT IS NOT A WINNER OF ANY PRIZE, EVEN IF THE ONLINE SCREEN INDICATES THEY ARE, UNLESS AND UNTIL THE PARTICIPANT'S ELIGIBILITY AND THE POTENTIAL WINNING PLAY HAS BEEN VERIFIED AND THE PARTICIPANT HAS FULLY COMPLIED WITH THESE OFFICIAL RULES AND BEEN NOTIFIED THAT VERIFICATION IS COMPLETE. SPONSOR/PROMOTER WILL NOT ACCEPT SCREEN SHOTS OR OTHER PURPORTED EVIDENCE OF WINNING IN LIEU OF ITS VALIDATION PROCESS.

Participants may be required to successfully complete a Know-Your-Customer ("KYC") Verification process provided by the Sponsor to validate eligibility to participate before redeeming any Prize. This may include, but is not limited to, providing proof of a valid government-issued photo identification, biometric facial scan recognition, proof of address, and validation of SSN.

Potential Prize winners must comply with these Official Rules, and winning is contingent upon fulfilling all requirements.

If a potential winner cannot be contacted, fails to properly execute and return any required affidavit/declaration of eligibility and liability/publicity release within the required time period (if applicable), fails to comply with these Official Rules, or if the Prize or Prize notification is returned as undeliverable, that potential winner forfeits the Prize.

## **9. Prizes and Prize Redemption**

The right to receive a Prize cannot be transferred or assigned.

The Prize is subject to availability, and if the Prize cannot be awarded for any reason, Sponsor reserves the right in its sole discretion to substitute the Prize with one of comparable or greater retail value. No Prize substitution is permitted, except at the sole discretion of the Sponsor. We reserve the right, in our sole discretion, to refund purchases in lieu of processing a Prize redemption.

Sponsor reserves the right to charge handling and/or payment processing fees for processing the redemption of Prizes.

Each winner is solely responsible for all federal, state, local, or other applicable taxes associated with the acceptance and use of the Prize. Each winner agrees and acknowledges that Sponsor may be required to withhold and remit a portion of Prize value to comply with applicable tax laws. Each winner also agrees to provide Sponsor with a valid

social security number or any other information Sponsor may require in connection with applicable tax reporting or withholding requirements or other laws or regulations.

All costs and expenses associated with Prize acceptance and use not specifically provided herein are the responsibility of the winner.

Redemption requests that meet applicable requirements, including successful identity verification and fraud checks, may be automatically approved. We aim to process approved redemption requests promptly. Processing times may vary depending on verification status, payment method, and third-party payment processor handling times. In certain cases, including but not limited to security reviews, fraud checks, or technical considerations, additional processing time may be required. For Participants with larger redeemable balances, Sponsor may, at its sole discretion, offer an alternative payout structure, including accelerated installment arrangements that exceed standard daily redemption limits, subject to approval and compliance review. All processing timelines are estimates only and are not guaranteed.

We will only process one Prize redemption request per customer account in any 1 day period.

A Participant may submit only one Prize redemption request in any twenty-four (24) hour period, and only one redemption request may be pending at a time. A Participant may not submit a new redemption request while a prior request remains pending, under review, incomplete, unpaid, declined, or otherwise unresolved. Redemption requests may be approved automatically or may be subject to manual review depending on amount, VIP tier, account standing, risk review, verification status, payment method, payment-provider requirements, and other factors. Processing timelines shown on the Platform are estimates and are not guaranteed. Weekends, holidays, payment-provider delays, verification issues, suspicious activity reviews, technical issues, and additional compliance checks may extend processing time.

Unless otherwise displayed on the Platform and subject to jurisdiction-specific limitations, the following VIP-based redemption framework may apply: Bronze, Silver, and Gold users may have a minimum redemption amount of \$30, a maximum of \$5,000 per request, and a monthly redemption limit of \$150,000; Platinum, Diamond, and Master users may have a minimum redemption amount of \$100, a maximum of \$10,000 per request, and a monthly redemption limit of \$300,000. Estimated review times may vary by VIP tier and may be displayed on the Platform. All such limits and timelines are discretionary, subject to change, and subject to successful KYC, fraud checks, account standing, payment-provider rules, and applicable law. If a state-specific maximum redemption limit is lower than a displayed platform limit, the state-specific limit controls.

Unless otherwise specified on the Platform, participants must have at least one hundred (100) sufficiently played-through Capy Coins in order to submit a redemption request for any Prize. Maximum daily redemption limits may apply and may vary based on a Participant's VIP tier status, account standing, and other factors as determined by Sponsor. Applicable redemption limits will be displayed on the Platform at the time of redemption. All redemption requests remain subject to verification, fraud checks, and compliance review. Sponsor reserves the right, at its sole discretion, to limit, adjust, delay, or deny any redemption request. In certain cases, including for Participants with larger redeemable balances, Sponsor may offer alternative payout structures, including accelerated installment arrangements that differ from standard daily limits, subject to approval. VIP Tier Impact on Redemption: Certain redemption limits, benefits, or processing priority may vary depending on a Participant's VIP tier status. All such benefits are discretionary and subject to change at any time.

The maximum redemption of a Prize won by a single participant during any Sweepstakes Entry Period is limited to the value of US \$5,000 in Florida per Sweepstakes Entry Period ("Maximum Redemption"). Any requested redemption in excess of the Maximum

Redemption will not be paid to the participant during the period, but must be deferred until the next Sweepstakes Entry Period. Redemptions may only be processed upon successful completion of our identity verification ("KYC") and redemption method verification procedures. All redemption methods must be registered in the same name as the User Account. Participants may be required to provide proof of ownership of any payment methods used in connection with Orange Coin ("OC") purchases on the Platform. Any falsification, alteration, or misrepresentation of documentation may result in immediate suspension or permanent closure of the User Account and forfeiture of any Capy Coins or Prizes. If a Participant's total redemption value equals or exceeds \$600, the Participant may be required to provide a valid Social Security Number or other tax documentation prior to redemption for tax reporting purposes.

You acknowledge and agree that we may, in our sole discretion, from time to time, appoint one or more payment administration agents to accept payments from players on our behalf. A payment administration agent will have the same rights, powers and privileges that we have under the Terms and these Official Rules and will be entitled to exercise or enforce their rights, powers and privileges as our agent or in their own name. In no event shall we be liable to any player for any loss, damage or liability resulting from the payment administration agent's negligence and/or acts beyond the authority given by us.

If we mistakenly credit your User Account at any time with Capy Coins that do not belong to you, whether due to a technical error, human error, or otherwise, the amount will remain property of Sponsor and will be deducted from your

Customer Account. If you have been issued a Prize that does not belong to you, the value of the mistakenly issued Prize will (without prejudice to other remedies and actions that may be available at law) constitute a debt owed by you to us. In the event of an incorrect crediting, you are obliged to notify customer support at support@capyspin.us. Sponsor, at all times, reserves the right to deduct Capy Coins from your User Account or otherwise charge or adjust your account to correct errors.

It is your responsibility to retain copies of transaction records and these Official Rules as updated from time to time.

For tournaments or leaderboard promotions, Prize descriptions and approximate retail values may be stated in Capy Coins or equivalent USD values for publication and winners-list purposes. Tournament winners are potential winners until eligibility, scoring, account standing, and compliance review are complete. Sponsor may require minimum qualifying activity for leaderboard eligibility and may disqualify entries generated through automation, collusion, coordinated play, multiple accounts, bonus abuse, technical exploitation, or other activity that undermines fair play.

## 10. Disputes

Section 16 of the Terms (Binding Arbitration and Class Action Waiver Agreement) is incorporated herein by reference with the same force and effect as though fully set forth herein. By agreeing to these Official Rules, you agree to be bound by Section 16 of the Terms.

## 11. Entry Conditions & Release

**By participating, each Participant agrees to:**

**(a) comply with and be bound by:**

- i. the Terms of Use, including without limitation, any ethical provisions as set forth in the Terms of Use;
- ii. these Official Rules; and
- iii. the decisions of the Sponsor which are binding and final.

(b) release and hold harmless the Sponsor/Promoter and its parent, subsidiary, and affiliated companies, the Prize suppliers and any other organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes, and all of their respective past and present officers, directors, employees, agents and representatives (collectively, the "Released Parties") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury arising out of or relating to a Participant's entry, creation of an entry or submission of an entry, participation in the Sweepstakes, acceptance or use or misuse of Prizes (including any travel or activity related thereto) and/or the broadcast, and exploitation or use of entry.

## 12. Publicity

Except where prohibited by law, by accepting a Prize, the winner hereby grants Sponsor and its representatives an irrevocable, perpetual, worldwide, royalty-free, non-exclusive and sub-licensable right and license to use, distribute, and publicly display the winner's name, the contents of any posts, and information about the Prize award, in any way, at any time, in any and all media, including without limitation, for use in advertising and marketing, without any additional approval or consideration. By accepting a Prize, the winner represents and warrants that he or she has the right to grant the foregoing license.

## 13. Damages and Disqualification

Sponsor may actively seek damages from any person acting in bad faith to undermine the legitimate function of the Sweepstakes to the fullest extent permitted by law. You may be disqualified from the Sweepstakes if you violate these Official Rules or our Terms or Use.
